Notice of Change in Assessment

The value on this notice reflects your home's proposed assessed value. It is important that you carefully review the notice, as any change in your assessed value will be reflected on your second-installment tax bill payable in 2010. Due to a permit action, we have determined there have been changes in the characteristics of your property.

Recently, changes were made to a county ordinance in order to adjust the assessment levels used to calculate assessed values in 2009. As a result, the proposed 2009 assessed value referenced above was determined using the new assessment level of 10%. Please note this new assessment level does not necessarily result in a lower assessment for your property in 2009.
